NASCAR Division II and Greenville-Pickens Speedway Track Points will be awarded for this event. All drivers must have a valid NASCAR Charger Division license (or above) that has not been suspended or revoked. Any NASCAR issued fines must be paid. Photo identification will be required at registration. \$200 pole award to fastest qualifier.

TRACK TIRE RULE: All trucks must run Hoosier F-45. Tires used in practice, qualifying and the race must be purchased and mounted at the track and will be impounded. Trucks will be required to qualify in time trials on new sticker tires and start the race on the same tires. Practice tires will be available for practice on Sunday.

TRACK FUEL RULE: All trucks must use Turbo Blue fuel purchased at the track. Fuel must be used exactly as supplied by fuel dispensing equipment at the track.

Qualifying Procedure: All drivers must attempt to qualify for this event. Starting positions 1 thru 24 will be assigned by order of qualifying time. If duplicate qualifying times are recorded, the first truck to qualify in the qualifying order will be awarded the qualifying position. The Promoter reserves the right to add positions to the starting field.

Race Procedure: Will be explained in driver meeting.

Special Rules: Eligibility Requirements: In the event of any conflict between the Rule Book, the Official Entry Blank and the special rules, the track officials will determine the interpretation and application of the conflicting rules and their decision will be final. ENTRY REGULATIONS: There is a **\$75** inspection fee for this event. Drivers do not have to pre-register for this event.
